#### **MAIN PURPOSE OF THE JOB:**

- 3 Lead on any contractual disputes and land compensation tribunal/adjudication claims, dealing directly with senior legal representatives of the counterparty organisations.
- 4 Provide legal interpretation of the Board's contractual obligations that will contribute to the establishment of business processes and staff guidance to ensure the delivery of high quality performance across the team that satisfies contractual obligations.
- 5 Liaise and lead in negotiations with third parties and their legal advisers on matters connected with the Mersey Gateway Bridge project.
- 6 Lead on the amendment of, or extensions to, existing statutory powers required to
