- Indicate the elections that could be used by Ms. Flack to reduce the amount of any income that would occur as a result of a sale of the properties at FMV to the corporation.

During much of this period you have constantly reminded her that there would be many advantages associated with incorporation, including the availability of the small business deduction. However, in late 2022, you have finally convinced her that incorporation may be the best course of action.

She indicates that she is still concerned with respect to income tax that might arise on the incorporation of her business. In response, you have indicated that ITA 85(1) provides a method that will result in little or no income tax. As a consequence, she agrees to proceed with incorporation. She will be the only shareholder of the newly incorporated CCPC Speaks Inc.
