 - (i) Fix a plain paper on the drawing board using the thumb pins.
 - (ii) Place the rectangular glass prism on the paper and trace its outline ABCD.
 - (iii) Draw a normal N_1 to meet AB at O such that $\angle AOB$ is 4 cm .
 - (iv) Draw an incident ray, MO, such that it makes an angle, $\theta = 65^\circ$ with AB.
 - (v) Place two optical pins P_1 and P_2 on MO and replace the glass prism on its outline.
 - (vi) View P_1 and P_2 from DC and place two other pins P_3 and P_4 such that they lie in a straight line with P_1 and P_2 . Remove the glass block.
 - (vii) Draw a line to join P_3 and P_4 to meet DC at E. Draw another normal N_2 at E and join EO.
 - (viii) Draw a circle of radius 3 cm with the centre at O and draw lines XY and QR perpendicular to N_1 .
 - (ix) Measure and record the lines XY and QR. Evaluate $\gamma = (XY + QR)$.
 - (x) Repeat the procedure for $\theta = 55^\circ, 45^\circ, 35^\circ$ and 25° respectively. In each case, measure and record r , XY, QR and γ .
 - (xi) Tabulate your readings.
 - (xii) Plot a graph of γ on the vertical axis and QR on the horizontal axis starting both axes from the origin, (0,0).
 - (xiii) Determine the slope, s , of the graph.
 - (xiv) Evaluate $S-1$.
 - (xv) State two precautions taken to ensure accurate results. (attach your traces to your answer booklet)
