##### **R = EXPLAIN THE LEGAL RULES**

The legal rules need to be explained in detail. Explain any legal terminology, explain the rules and how they operate. Back up the rules by referring to legal authority – cases and/or statutes. Make sure you explain all relevant issues. This part of the answer is very important and requires careful attention.

##### **A = APPLY THE LAW TO THE FACTS**

Here you will apply the law to the facts in detail. Please note that you are not repeating the law here. You are applying the law. You will bring out information from the scenario in doing so. So, you need to use the names of the parties and use the facts presented in a scenario and apply the law accordingly these. This part is also very important and requires careful attention.

##### **C = CONCLUSION**
