- 5 Maintain clean and organized work areas to prevent accidents
- 6 Regularly inspect and maintain equipment and machinery
- 7 Clearly mark and keep emergency exits and evacuation routes accessible
- 8 Promote and enforce safe lifting and material handling practices
- 9 Report and investigate all incidents and near-misses to prevent recurrence
