IAS 27: Consolidated and Separate Financial Statements - version 2008 (summary)Para 1-3: **Scope of IAS 27:**

Applicable for preparation and presentation of consolidated financial statements for a group entity but does not deal accounting treatment of goodwill as per IFRS 3. Also applicable if a group entity presents separate financial statements.

Para 4: **Definitions:**
