SUBJECT: Accreditation of Cargo Data Exchange Center, Incorporated

Effective 29 January 2015, the PEZA e-systems (e.g. Electronic Import Permit System, Automated Export Documentation System and Electronic Import Permit System for Ecozone Logistics Service Enterprises) previously operated and managed by Apollo Technologies, Incorporated (Apollo) have been turned-over to Cargo Data Exchange Center, Incorporated (CDEC). CDEC, a BOC-accredited VASP, has now been accredited as PEZA VASP, replacing Apollo.

In this connection, personnel from Apollo shall no longer be allowed access to the PEZA e-systems. All issues and concerns related to the e-systems previously operated by Apollo should now be addressed to CDEC.
