After the development of the International Financial Reporting Standards IFRS by the International Accounting Standard Board IASB in 2001 the European Union EU decided to unify the jurisdictions for all listed corporations and therefore decreed a mandatory adoption of IFRS in the EU. The EU reasoned that common accounting standards improve capital market efficiency and reduce information processing and auditing costs. However the decisive reason for the adoption of IFRS was that today's global economy requires global standards to ensure transparency, accountability and comparability of financial accounts.
