This part of the book contains specific chapters dedicated to bulk drug substances and finished products, dissolution studies, robotics and automated workstations, biotechnology products, biological samples, analytical methods for cleaning procedures and computer systems, and computer-aided validation. Each chapter goes into some detail describing the critical development and related validation considerations for each topic.
