



Access to Medical Reports Act 1988

1988 CHAPTER 28

An Act to establish a right of access by individuals to reports relating to themselves provided by medical practitioners for employment or insurance purposes and to make provision for related matters. [1988 July 1988]

BE IT ENACTED by the Queen's most Excellent Majesty, by and with the advice and consent of the Lords Spiritual and Temporal, and Commons, in this present Parliament assembled, and by the authority of the same, as follows:—

1. It shall be the right of an individual to have access, in accordance with the provisions of this Act, to any medical report relating to the individual which is or has been, or is to be, supplied by a medical practitioner for employment purposes or insurance purposes.

Right of access

2. (1) In this Act—

Interpretation

“the applicant” means the person referred to in section 1(1);

“test” includes examination, investigation or diagnosis for any purpose or, in its ordinary sense, any form of medical treatment;

“employment purposes”, in the case of any individual, means the purposes in relation to the individual of any person by whom he is or has been, or is seeking to be, employed (whether under a contract of service or otherwise);

“health professional” has the same meaning as in the Data Protection (Health and Miscellaneous Provisions) (England) Order 1982;

“insurance purposes”, in the case of any individual, means the purposes in relation to the individual of any person carrying on an insurance business with whom the individual has entered into, or is seeking to enter into, a contract of insurance, and “insurance business” and “contract of insurance” have the same meaning as in the Insurance Companies Act 1982.
