

## CHAPTER 1 - INTRODUCTION TO AS

**GAAP (Generally Accepted Accounting Principles)** – common set of accounting principles, standards, and procedures that a business reporting entity must follow while preparing and presenting financial statements. Globally known as IFRS (International Financial Reporting Standards), in India they are AS (Accounting Standards) and Ind AS (Indian Accounting Standards).

### **ACCOUNTING STANDARDS (AS)**

written policy documents issued by the Government with support of regulatory bodies like MCA (Ministry of Corporate Affairs) and NFRA (National Financial Reporting Authority). They govern four key aspects of financial transactions or events: recognition, measurement, presentation, and disclosure.

**PURPOSE OF AS:** to promote dissemination of timely, reliable, and useful financial information to investors and stakeholders interested in the company's performance. AS reduces accounting alternatives and ensures comparability among financial statements of different enterprises.

**COMPONENTS OF AS:** recognition of transactions and events, measurement of transactions and events, presentation in a meaningful and understandable manner, and disclosure to provide insight and help in prudent business decisions.

### **BENEFITS OF AS:**

- **STANDARDISATION OF ACCOUNTING TREATMENTS** – AS reduces confusion by eliminating variations in treatment of economic events. They offer standard policies (e.g. for inventory valuation, depreciation, amortisation) but still require disclosure of the actual policies used, e.g. FIFO or Weighted Average for inventory as per AS 1 (Disclosure of Accounting Policies).
- **ADDITIONAL DISCLOSURE REQUIREMENTS** – even if not legally required, AS may require disclosures of accounting policies and other relevant information to enhance understanding of financial statements.
- **COMPARABILITY OF FINANCIAL STATEMENTS** – AS improve comparability both intra-enterprise (same entity over different periods) and inter-enterprise (different entities in the same period). Intra-enterprise comparison needs consistent policies over years. Inter-enterprise comparison needs similar or disclosed accounting policies to allow meaningful analysis.

**JUDGEMENT IN APPLICATION** – AS are principle-based, so applying them to complex transactions requires judgement. However, *in case of conflict with law, statutory requirements override AS.*

**REDUCTION IN CREATIVE ACCOUNTING** – refers to the manipulation or twisting of accounting policies to produce financial statements favourable to a specific interest group. Example: Overstating profits/assets by capitalising revenue expenditure or understating them by writing off capital expenditure as current expense. AS help curb creative accounting by giving guidance for treatment of such borderline cases.
