(i) An agreement to sell a Land for ₹ 30 Lakhs to another Company was entered into on 1 <sup>st</sup> March 2013. The value of Land is shown at ₹ 20 Lakhs in the Balance Sheet as on 31 <sup>st</sup> March 2013. However, the Sale Deed was registered on 15 <sup>th</sup> April 2013.	Similar to Page B.1.5, Q No. 13, Point 1. It is a Non-Adjusting Event.
(ii) The negotiation with another Company for acquisition of its business was started on 2 <sup>nd</sup> February 2013. Pradip Ltd invested ₹ 40 Lakhs on 12 <sup>th</sup> April 2013.	Similar to Page B.1.3, Q No. 5 It is a Non-Adjusting Event.

**Question 1 (b) AS – 5 Disclosure of Change in Method of Depreciation**

**5 Marks**

Cost of a Machine acquired on 01.04.2009 was ₹ 5,00,000. The Machine is expected to realise ₹ 50,000 at the end of its working life of 10 years. Straight-Line Depreciation of ₹ 45,000 for the year has been charged upto 2011-2012. For and from 2012-2013, the Company switched over to 15% p.a. Reducing Balance Method of Depreciation in respect of the Machine. The new rate of Depreciation is based on revised useful life of 15 years. The new rate shall apply with retrospective effect from 01.04.2009. Show how would you deal with the above in the annual accounts of the Company for the year ended 31<sup>st</sup> March 2013 in the light of AS-5.

**Solution:**

Refer Page B.2.4, Q No.19, 21 and AS-6.

1. **A change in an Accounting Policy should be made only –**

- (a) If the adoption of a different accounting policy is required by Statute, or
- (b) For compliance with an Accounting Standard, or
- (c) If it is considered that the change would result in a more appropriate presentation of the Financial Statements of the enterprise.

2. **Disclosure Requirements of Changes in Accounting Policies:**

- (a) **Disclosure:** Any change in an accounting policy, which has a material effect should be disclosed.
- (b) **Current Effect of Change:** The impact of, and the adjustments resulting from such change, if material, should be shown in the Financial Statements of the period in which such change is made, to reflect the effect of such change. Where the effect of such change is not ascertainable, wholly or in part, the fact should be indicated.
- (c) **Future Effect of Change:** If a change is made in the accounting policies which has no material effect on the Financial Statements for the current period but which is reasonably expected to have a material effect in later periods, the fact of such change should be appropriately disclosed in the period in which the change is adopted.
